

Car Spa, Inc. House Account Program

Car Spa has a program designed to manage House Accounts. House accounts are billed weekly with a single invoice. In some cases, accounts will have net 30 terms to pay on invoices. To qualify for this program, we need you to fill out the House Account Application and Info sheet and return with all information completed in order to be considered. There is no upfront fee associated with starting a House Account however we do require a minimum spend of \$100 weekly in services. Not meeting the required spend may result in a \$25 monthly fee or account suspension.

The House Account Application requires the following information:

- Business Data
- Personal Guarantee of payment
- Bank References
- Trade References

Processing Highlights

- Car Spa will bill you once a week for all monthly transactions.
- Possession of a card **is not** required to charge a service your account.
- You will receive a weekly statement of activity.
- Payment is typically set up on net terms so you can pay multiple invoices at a time based on date issued.
